Innovative Mechanics

Create New Company: Newco, LLC NAICS Code: 561320 Staffing

Newco LLC contracts with tribe

Provide 2 positions for housing, 1 for Voc Rehab, 2 for health programs



Newco LLC

With the 5 transferred employees, Newco has

- \$50k plus 20% = \$60,000 per person per year
- 5 employees = \$300,000 per year contract (Current)
- 5 year contract = \$1,500,000 (Backlog of work)
- Government contracting experience (Tribe)



Sample Org Chart



The Board of Directors of the Corporation has control over the direction and business activities of the Corporation.

The Tribal Council is not involved in the day-to-day activities of the Corporation, but rather sets strategic economic policies for the Tribe.

Corporation can create or acquire multiple subsidiaries.



Factors to Consider

Grants allow indirect: generally 25-40% for Tribes.

Grants do not allow indirect on sub-contracts

Sub-contractors are EXPECTED to make a profit

Tribe can include Newco, LLC in grant applications

The profit going to Newco LLC offsets the reduction of indirect; total monies to the tribe are the same.



Organizational Structure

- Section 17 Corporation (federally recognized tribes only)
 - Non-profit, tax exempt, perpetual, 100% tribally owned
 - Can charter for-profit subsidiaries
 - Can create partnerships, LLC's
 - Tax exempt and non-affiliated

Summary

≻Tribal governments provide services to their citizens.

- ≻Tribes often contract for some of these services.
- ➤Tribes can create company and contract with themselves

➤Tribes can also contract with other government agencies
